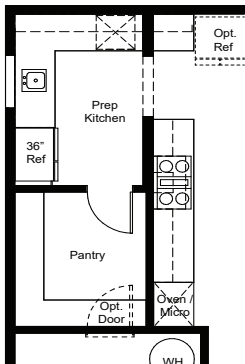
Optional Rear Enhanced Elevation  
at Floor 1



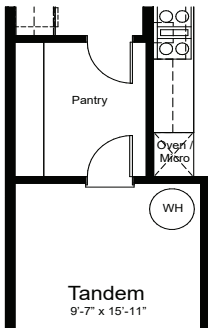
